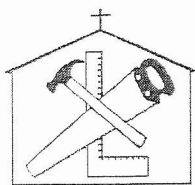

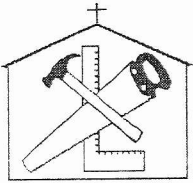

Program with prior knowledge of the nature of its work and activities. The above
mentioned volunteer will hold harmless the Catholic Church of Preston County and
any of its parishes and missions, Catholic Charities West Virginia and any of its local
affiliates, the St. Vincent de Paul Society, the Diocese of Wheeling-Charleston, the
Bishop of the Diocese of Wheeling-Charleston, and all staff, parishioners and
volunteers of the above groups, from any and all liability or injury associated with the
Summer Home Repair Program. The above mentioned volunteer also understands that
the Catholic Church of Preston County does NOT provide medical insurance or
coverage to the participants of the Summer Home Repair Program, and that it is the
above mentioned volunteer's responsibility for coverage should any medical situation
arise either during or after his or her stay in Preston County. It is also understood that
the Catholic Church of Preston County maintains adequate liability insurance on all of
its properties.
